



"Buncee Student Artist Contest"

Students, publish your art on Buncee! Create a sticker, animation, or background, and submit your artwork for possible inclusion on Buncee's online tool and mobile application. All students are eligible. Featured Student Buncee Artists will have their artwork displayed for use on the Buncee website and mobile app under the "Student Art" category in Stickers, Animations, or Backgrounds. By entering the contest, you and your parent/guardian agree that all submitted Student Art is the property of Buncee LLC for use on its website, mobile apps, and promotional materials.

Student Art can be submitted via email to bunceeartist@buncee.com. On a monthly basis, artwork submitted during the previous month will be reviewed by our Creative Committee, which includes a student and the creator of Molly Dolls; a world renowned teacher librarian, speaker, and author; an elementary school teacher and K-5 science/STEM leader; and an esteemed author. Featured Student Buncee Artists will be chosen once per month. Each individual piece of Student Art can be submitted once. Students may submit multiple pieces of Student Art under each category: Stickers, Animations, and Backgrounds.

Contest Rules

1. Sponsor

The contest is sponsored by Buncee LLC, located at 170 Montauk Highway, Speonk NY 11972.

2. Prize

The grand prize that may be awarded to the eligible Featured Student Buncee Artists will be inclusion of submitted Student Art on Buncee's website and mobile application. The prize is not transferable, redeemable for cash or exchangeable for any other prize. All submitted Student Art is the property of Buncee LLC for use on its website, mobile app(s), and promotional materials.

3. Contest Period

The contest begins at 12:00AM EST on the first day of every month, beginning on March 1, 2019, and ends at 11:59PM EST on the last day of every month. This is a monthly, recurring contest. Entries that are submitted after the Contest Period will be considered in the subsequent round. Submissions will be accepted for the duration of the contest by emailing them to bunceeartist@buncee.com.

4. How to Enter

Students are required to have their teachers/school submit their entries by doing the following:

- Draw a sticker, animation, or background using any method desired
- Give your Student Art to a teacher to scan into a computer and save it as a PDF, JPEG, or PNG
- Attach the scanned Student Art to the teacher's email, and send it to bunceeartist@buncee.com
- Include the student's name, grade, school, and nickname of the Student Art within the body of the email
- Make sure the email Subject states "Student Art"

5. Prize Drawing

During the first week of every month, the Creative Committee will select the Featured Student Buncee Artists from Student Art submitted during the previous month. The Featured Student Buncee Artists will be notified via the teacher's email address used to submit the Student Art. Their submitted Student Art will be displayed for use on the Buncee website and mobile app under the "Student Art" category in Stickers, Animations, or Backgrounds. Featured Student Buncee Artists will also receive a special Buncee Badge - Buncee Student Artist!

6. Eligibility and Limitations

Participants and winner(s) can reside within the U.S., or outside of the U.S. By participating in the submission portion of this contest, each participant agrees to be bound by the official contest rules. If an entry received does not seem to be the authentic work of a student, Buncee LLC reserves the right to disqualify the entrant in its sole discretion. Images from the internet such as Google or Bing images may not be submitted. Any images submitted must not be subject to United States Copyright laws. All decisions of the Creative Committee are final.

7. Publicity; Use of Personal Information

By participating, where allowed by law, all participants and Featured Student Buncee Artists grant Buncee, LLC exclusive permission to use their names, characters, likenesses, and artwork in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. By participating in the contest, where allowed by law, participants agree that Buncee, LLC may use information obtained from participants in the contest for marketing and other purposes.

8. Consumer Created Content

By submitting your entry: (1) you agree that your disclosure is gratuitous, unsolicited and without restriction and will not place buncee.com or contest sponsors under any fiduciary or other obligation, that Buncee LLC is free to disclose the ideas on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to you; (2) you

acknowledge that, by acceptance of your submission, Buncee LLC and contest sponsors do not waive any rights to use similar or related ideas previously known to sponsor, or developed by their employees, or obtained from sources other than you; (3) you are verifying that you are the owner and producer of the submitted material and that no third party ownership rights exist to any material submitted, and (4) you are hereby granting Buncee LLC a perpetual, worldwide, non-exclusive, royalty-free, sub-licensable (through multiple tiers) right and license to use, publish, reproduce, display, perform, adapt, modify, distribute, have distributed and promote such content in any form, in all media now known or hereinafter created, anywhere in the world, for any purpose.

By participating in the contest, all participants and Featured Student Buncee Artists agree to release and hold harmless Buncee LLC, and waive any and all claims of liability against Buncee LLC, its employees and agents, the contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the contest, or from the use of any prize.

10. Conduct and Decisions

By participating in the contest, participants agree to be bound by the decisions of the Creative Committee. Persons who violate any rule, gain unfair advantage in participating in the contest, or obtain Featured Student Buncee Artist status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. Buncee LLC will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the contest and Buncee LLC's decisions concerning such disputes shall be final. If the conduct or outcome of the contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of Buncee LLC, Buncee LLC reserves the right to terminate this contest, or make such other decisions regarding the outcome as Buncee LLC deems appropriate. All decisions will be made by Buncee LLC and are final. Buncee LLC may waive any of these rules in its sole discretion.
